Review of Show Schedule – Proposals

Niki, Chair, provided the committee with three different draft proposals provided by the sub-committee that agreed to design a 2015 show schedule. Brittany reviewed the drafts for the committee members on behalf of the sub-committee.

Discussion were held by various committee members to discuss the variance in the proposed schedules. Concerns were expressed by members and addressed by Brittany.

Discussion of adding a Walk/Trot class was held. Brittany stated that the walk/trot classes would give 4-H youth an opportunity to participate that are not quite ready for the other classes. Anne asked if those participating in the walk/trot classes could cross over to the other classes. Brittany stated that this was not an option.

After much deliberation, a motion was put on the table by Jim to add the walk/trot classes into the show. Laurie seconded the motion. The vote was unanimous that the classes would be added this year. Youth cannot enter in these classes and cross over to the other classes. Walk/trot participants will also be asked to sign up for halter and showmanship classes. It was emphasized again that the walk/trot classes added are not eligible for state points or state competition. In addition, youth participating in the walk/trot would receive ribbons of participation or competition from the committee, not the state awards.
