RULES & REGULATIONS

4-H RABBIT SHOW PARTICIPANTS MUST ABIDE BY THE ALL GENERAL RULES AND HEALTH REGULATIONS.

- 1. All entries must participate in the Department 190 Rabbit Exhibit.
- 2. Any bona fide 4-H member may show a rabbit that they have had on display in Department 190 Rabbit Exhibit. All 4-H members must have reached their 5th birthday and have not passed their 19th birthday by September 1 of the current 4-H year; they must be enrolled in a rabbit project, which is certified by their respective extension agent, the 4-H exhibitor must show animals.
- 3. Rabbits must be owned and in possession of the 4-H exhibitors or exhibitors family at least 45 days prior to the date of show. All rabbits must be at least 8 weeks of age at time of show.
- 4. Participation in the 4-H Rabbit Record Book Contest is a requirement to participate in the 4-H Rabbit Showmanship Contest. Record books will be judged. First place winners will receive a rosette.
- The American Rabbit Breeders Association rabbit showmanship standards will be used for judging purposes. The document can be reviewed at https://www.arba.net/PDFs/Showmanship.pdf
- 6. Division A 4-H Cloverbud division will not be judged. All participants in the 4-H Cloverbud division will receive participation certificates.
- 7. ENTRY FORMS CAN BE FILLED OUT AND THEN PRINTED. ALL FORMS MUST BE COMPLETE OR THEY WILL NOT BE ACCEPTED. All incomplete forms will be returned. If you have any questions about what is acceptable please call the Chairperson of Fair Office.
- 8. 4-H Exhibitors should be dressed neatly and professionally.
