


## **Wiregrass Forage Based BCIA Bull Evaluation – Driving Directions**

**From Brantley, AL** – travel 4.1 miles Southeast on Highway 331, turn left on Highway 141 South (located 0.9 miles past Kennedy Road and 0.2 miles prior to Weed Road) and travel 14.4 miles (\*Note: Highway 141 intersects Highway 84, to proceed on Highway 141 South – turn left at intersection, then proceed ~100 yards and turn right to continue on Highway 141 South) to junction of Highway 189, turn right (South) and travel 0.7 miles on Highway 189 South to Coffee County Road 420 intersection, turn right (West) on Coffee County Road 420 and travel 0.5 mile and turn left (South) on Coffee County Road 425 (a gravel, dirt path) into the entrance of the bull evaluation site.

**From Elba, AL** – traveling from Highway 84, turn South and travel on Highway 189 South for 6.5 miles to the Coffee County Road 420 intersection (located just South of Highway 141 & 189 junction and the Basin Baptist Church), turn right (West) on Coffee County Road 420 and travel 0.5 mile and turn left (South) on Coffee County Road 425 (a gravel, dirt path) into the entrance of the bull evaluation site.

**From Enterprise or Opp, AL** – traveling from Highway 134, turn North (at Perry Store Community intersection) and travel on Highway 189 North for 4.6 miles to Coffee County Road 420 (located just South of Highway 141 & 189 junction and the Basin Baptist Church), turn left (West) on Coffee County Road 420 and travel 0.5 mile and turn left (South) on Coffee County Road 425 (a gravel, dirt path) into the entrance of the bull evaluation site.

Dear Beef Cattle Producers:

On behalf of the consignors and management of the Wiregrass Forage Based BCIA Bull Evaluation, I invite you to join us on Saturday, October 27, 2012 at 12:00 noon for the 23<sup>rd</sup> Annual Bull Sale. The sale will be held at the Advance Genetic Resource Farm (the bull evaluation site), located 6½ miles south of Elba, Alabama, just off Highway 189.

These coming 2 year old bulls (24 – 21 months of age) offer an outstanding opportunity to producers to make those important genetic selections and add quality herd sires to the cowherd. These bulls are rugged and well adapted, as they have been performance tested in this impartial, centralized test and developed on grass over the past 11 months. The bulls are test negative for Trichomoniasis and eligible for interstate shipment.

Individual bull performance for growth was collected during the 145-day grazing evaluation. In addition, Expected Progeny Differences (EPDs), yearling ultrasound data for carcass traits, scrotal circumference and hip height (frame score) information was collected on each bull. This information and other bull facts are presented in the bull sale catalog to assist in the analysis and selection of these evaluation bulls.

Current feeder calf prices remain near historic highs. Expectations for these higher feeder calf prices to continue are strong with feeder calves in short supply and the U.S. cowherd expansion limited by drought conditions. Input costs (feed, fertilizer, fuel ...) for cow-calf production continue to rise and pressure the profit margins of most operations.

Now more than ever, with higher corn and feed prices, beef producers must lean heavily on grazing forages to supply the nutrition for their cowherd and calves. Since feed is the single largest expense for most beef operations, the ability to make gains on grass is extremely important. The Wiregrass Forage Based BCIA Bull Evaluation offers prospective herd sires with documented performance on grass.

An open invitation is extended to beef cattle producers to visit the evaluation site and view the 67 bulls offered. There are 32 Angus, 2 Beefmaster, 6 Charolais, 3 Chianina Percentage, 11 Simmental and 13 Simmental Percentage bulls, respectively, scheduled to sale. However, each bull must pass a Breeding Soundness Examination later this month to gain their final entrance to the sale.

The warranties and guaranties set forth in these "Sale Terms and Conditions" are in lieu of all other warranties either expressed or implied, and the remedies provided therein shall be the sole and exclusive remedy of the buyer, or any party claiming through buyer, for any breach of warranty or guarantee therein provided, and all other obligations or liabilities.
<b>Liability</b>	<u>All persons attending the sale do so at their own risk.</u> The Wiregrass Forage Based BCIA Bull Evaluation (agents, board, committee, consignors, managers, representatives, staff, superintendent, sponsors, veterinarian and workers), Advance Genetic Resource, LLC, Alabama Beef Cattle Improvement Association, Alabama Cooperative Extension System, Alabama A&M University or Auburn University will not assume any liability, legal or otherwise, for the safety of those attending this sale.
<b>Time and Location</b>	The 23 <sup>rd</sup> Annual Wiregrass Forage Based Bull Evaluation Sale will be held Saturday, October 27, 2012 at 12:00 p.m. at Advance Genetic Resource, LLC farm in Elba, Alabama.
<b>Bidding</b>	All animals will be sold to the highest bidder without reserve. The auctioneer will settle any disputes in bidding and his decision on such matters is final. Mailed or telephoned bids will be handled in a most confidential manner. If you are unable to attend the sale in person, please contact the Michelle Elmore, Rickey Hudson or the auctioneer (Mr. Carroll T. Cannon: 229-881-0721) for assistance in bidding.
<b>Payment Terms</b>	The terms of the sale are cash or check unless credit arrangements, including any possible reservation of security interest, have been made by the interested party with the vendor, Alabama BCIA, prior to sale. The party financially responsible for each purchase will be the person's name that registered to the purchasing buyer number.
<b>Purchaser's Risk</b>	Each animal becomes the purchaser's risk as soon as sold. It is advised to purchase insurance on each animal. Buyers are encouraged to transport their purchases on sale date. Arrangements need to be made in advance by the buyer for any animals held over for a later transport date.
<b>Insurance</b>	Insurance is available through Harding and Harding. Buyers wishing to insure their purchases may do so by contacting the sale clerk.
<b>Certificate of Registry</b>	A transferred certificate or registry will be furnished to the purchaser of each animal within forty-five (45) days following date of sale or receipt of full payment.
<b>Identification</b>	Seller offers each animal with a readable tattoo corresponding to its registration paper. Buyer agrees to check tattoo for accuracy. In those cases where a nickname is used, it shall be accompanied by the official registered name and number of the animal.
<b>Health</b>	All animals are eligible for interstate shipment. Interstate health certificates will be available for each animal upon request.
<b>Breeding Guarantee</b>	All animals are guaranteed to be breeders with the exception of: a) injury or disease occurring after sale; b) gross negligence or willful misconduct on the part of the purchaser. Any bull which settles cows by natural service and passes a fertility test by competent veterinarians, mutually agreed upon by buyer and seller, during any 6 month period of trial (as provided for in the " <i>Options and Privileges of Return or Adjustment</i> " section of these terms and conditions) shall be considered a breeder. Any guarantees with respect to the ability to freeze semen shall be by separate agreement between the buyer and seller.
<b>Options and Privileges of Return or Adjustment</b> <b>*Suggestions</b>	All claims for adjustment must be made in writing within six months of the sale date. In the event the animal may be returned to the farm of the seller, it shall be in good condition and complying with the health requirements of the seller's state. The seller shall be entitled to a six (6) month trial following the return of the animal in which to prove the animal is a breeder. If at the end of six months the seller is unable to prove the animal is a breeder, the seller shall, at the option of the buyer, replace the animal with another of equal value or refund the purchase price. The return of the full purchase price in any case shall be deemed full satisfaction and settlement. Any expense incurred from the transportation of an animal claimed to be a non-breeder shall be the responsibility of the purchaser, except that the seller shall be responsible for transportation costs in excess of the distance between the purchaser's farm and the location where the sale took place. If the seller proves the animal to be a breeder, it shall be the obligation of the purchaser to take delivery of the animal and pay all expenses incurred for transportation. *These " <i>Options and Privileges of Return or Adjustment</i> " are <u>suggestions</u> for voluntary use and consideration by sellers in their independent business judgment.
<b>Rights and Obligations</b>	The above terms and conditions of sale shall constitute a contract between the buyer and seller of each animal and shall be equally binding upon both. Each sale or resale of an animal constitutes a separate transaction.

## **ALABAMA BCIA POLICY ON GENETIC DEFECTS**

Alabama BCIA encourages all consignors to test their animals for any genetic defects as directed by their respective breed associations. The genetic defect status of animals to be sold in BCIA sales have been verified with the respective breed association by the sale coordinator. Any known carriers or potential carriers of a genetic defect are noted in the sale catalog. Any updates will be posted by a sale supplement sheet or vocally from the sale block for full disclosure of any known genetic defect. Therefore, all animals published in this catalog are free of any known genetic defects at the time of publication, unless noted.

### **CARE OF NEWLY PURCHASED PERFORMANCE TESTED BULLS**

Bulls need time to adjust to a new environment, prior to the start of a breeding season, no matter the type of performance testing system from which they were purchased. Often this time of adjustment is referred to as a "hardening period" or a "let down period".

Young bulls require attention to achieve continued growth and successful development. Proper feeding, good care and sound management gives young bulls an opportunity to grow into solid, profitable herd sires.

Good management practices help to ensure a long, productive service life for bulls. The following good management practices are suggested for developing young bulls into productive herd sires:

- Provide a secure area (pen) with fresh water and good quality hay at arrival.
- Provide feed for additional energy (approximately 1% of body weight), following initial consumption of water and hay at arrival.
- Allow adequate time to settle down and adjust to new surroundings before turn-out from secure area.
- If the turn-out of a bull into the cow herd at arrival is necessary, bring the cow herd to a holding area and release the bull into the herd before returning them to the pasture.
- Avoid the risk of severe injury or death of a new bull by never releasing him into a breeding pasture with a more mature bull.
- Avoid the excessive loss of body condition on a bull during the breeding season. Feed additional energy, as needed, to maintain body condition. Generally, a diet of pasture and hay will not meet the nutrient requirements of an active, growing, young bull.

- Provide a resting period of 1 to 2 weeks from heavy breeding service for young bulls, if necessary to maintain body condition.

- Limit the exposure of a bull to breeding females based on the age of the bull. The following guidelines list the corresponding ages of a bull to the maximum number of females that a bull is expected to service and settle during a breeding season (90 days):

<b><u>Age of Bull</u></b>	<b><u>Number of Females</u></b>
12-15 months	10 to 12
15-18 months	12 to 18
18-24 months	18 to 25
24 months & older	25 to 35

- Record the breeding dates of observed mating activities, as the non-return to heat is an indication that a female has settled. In a single sire mating system, this information indicates the ability of the bull to settle females.

- Provide internal parasite control immediately following the breeding season. Provide external parasite control as needed.

- House bulls in well fenced lots, before and after the breeding season, which controls the bull's access to females in heat and sets a defined breeding season.

- Provide ample shade and fresh, clean water in bull lots. Provide free-choice minerals and routinely treat for parasites.

\*\*\* Remember, a bull is only guaranteed to be a breeder by his evaluation consignors, if managed correctly after the sale. \*\*\*

## **Explanations of EPDs**

**BIRTH WEIGHT EPD (BW):** Predicts the differences in the average birth weight of calves sired by a bull compared to the average sired by other bulls within the breed. Larger Birth Weight EPD values indicate a heavier birth weight average for calves. Check **Table. 1**, to determine if a bull is above or below average within his breed.

**CALVING EASE DIRECT EPD (CE):** Predicts the ease with which calves of a bull are born to first calf heifers. Values are reported as deviations in the percentage of unassisted births. Larger Calving Ease Direct EPD values indicate less assisted births.

**FAT THICKNESS EPDs (RbFT=Rib Fat, RpFT=Rump Fat & BFat=Back Fat):** Predicts the differences in the average external fat thickness along the loin of calves at a given end point sired by a bull compared to the average sired by other bulls within the breed. Values are expressed in inch units.

**Note:** Ultrasound data for Rib Fat is measured between the 12th and 13th ribs. Breed associations vary in their reporting of ultrasound data for external fat thickness (some breeds report rib & rump fat, while other breeds only report back fat).

**MARBLING EPD (MB):** Predicts the differences in the average marbling (intramuscular fat) ability of calves at a given end point sired by a bull compared to the average sired by other bulls within the breed. Selection for larger Marbling EPD values does not increase external fat, as the genetic correlation between marbling (intramuscular fat) and external fat is nearly zero.

**MILK EPD (MM):** Maternal Milk EPD and Pure Milk EPD are other names for Milk EPD. Predicts the differences in the average adjusted 205-day weight of calves from direct daughters of a bull (due to their milking ability) compared to the average of daughters from other bulls within the breed.

**Note:** These values are reported as pounds of adjusted 205-day weaning weight of calves, not as pounds of milk.

**RIBEYE AREA EPD (REA):** Predicts the differences in average ribeye area (size) at a given end point for calves sired by a bull compared to the average sired by other bulls within the breed. REA is measured between the 12th and 13th ribs and expressed in square inch units.

**WEANING WEIGHT EPD (WW):** Predicts the differences in the average of adjusted 205-day weaning weight of calves sire by a bull compared to the average sired by other bulls within the breed.

**YEARLING WEIGHT EPD (YW):** Predicts the differences in the average of adjusted 365-day yearling weight of calves sire by a bull compared to the average sired by other bulls within the breed.

## **Definition of Terms**

**ACTUAL:** Recorded values as measured.

**ADJUSTED:** Calculated values used to standardize actual values which allow for comparisons between individuals.

**AVERAGE DAILY GAIN (ADG):** Weight gained per day during the 147 day (December 1, 2010 – April 27, 2011) bull evaluation. A measure of an individual's ability to gain weight on a forage diet.

**AVERAGE DAILY GAIN RATIO (ADG Ratio):** Calculated values to proportion ADG data between bulls within a breed group for comparison.

**EXPECTED PROGENY DIFFERENCES RATIO (EPD Ratio):** Calculated values to proportion EPD percentile data for Birth Weight, Weaning Weight, Yearling Weight and Milk between bulls within a breed group for comparison.

**FRAME SCORE (Frame):** Calculated values to standardize actual hip height values, that allow for height comparisons between individuals.

**GROWTH INDEX:** Calculated values ( $\frac{1}{2}$  ADG ratio +  $\frac{1}{2}$  WDA ratio) to compare total growth performance between bulls within a breed group for the 147 day evaluation.

**HIP HEIGHT (Hip Ht.):** Measured height from the level plane of the ground to a level plane over the top of the hip (hook).

**RATIO:** Calculated values to proportion data between bulls within a breed group for comparison. The average value of any ratio is 100. A value greater than 100 indicates the individual is above average within his group. A value less than 100 indicates the individual is below average within his group.

**SCROTAL CIRCUMFERENCE (Scrotal):** Measured distance (in centimeter units) around the widest portion of the scrotum with testicles distended. Scrotal circumference is an indicator of fertility for the bull and his daughters.

**TEST INDEX:** Calculated values ( $\frac{1}{3}$  ADG ratio +  $\frac{1}{3}$  EPD ratio +  $\frac{1}{3}$  WDA ratio) to compare total growth performance for the 147 day evaluation combined with expected progeny performance between bulls within a breed group. The bull sale order is based on Test Index.

**WEIGHT PER DAY OF AGE (WDA):** Off - Test (April 27, 2011) weight at the bull evaluation divided by a bull's age(in days). A measure of total weight gain by an individual.

**WEIGHT PER DAY OF AGE RATIO (WDA Ratio):** Calculated values to proportion WDA data between bulls within a breed group for comparison.
