FLORIDA FED BEEF CHALLENGE ENROLLMENT FORM

RULES AND REGULATIONS FOR THE FLORIDA-FED BEEF CHALLENGE

- Producer must commit by September 27, 2021 and cattle must arrive at the Etheridge Cattle Company Feed Yard on October 1, 2021.
- One entry (lot) must consist of 10 head from a single producer. A producer may enter more than one lot into the contest, as long as each lot consists of 10 head.
- Cattle will be commingled and feed together in one or more pens depending on number of entries.
- Breeds eligible - British, Continental or *Bos Indicus*. Can be purebred or crossbred. No dairy or dairy cross allowed.
- STEERS ONLY. Weights between 550-750 lbs with two of the 10 head group allowable 50 pounds on either side. Example 500-550 lbs or 750- 800 lbs on only two head of the group.

NEW THIS YEAR – In weight at the feedyard after a 14 day washout period (October 15th weigh start) will be used in the scoring system. Cattle that have all ten head in the 550-750 lb weight range will receive the highest points.

- Cattle must be weaned a minimum of 45 days prior to October 1 with two rounds of vaccinations (Respiratory and Blackleg) and one round of deworming prior to arriving at the feedyard.
- Cattle will be harvested at a current FCR harvest facility. The meat produced will be sold under the Florida Cattle Ranchers brand.
- Cattle must qualify under the FCR Protocols (i.e. born, raised and fed in Florida).
- All cattle will be given an EID at the feed yard if one is not present when they arrive.
- Cattle will be PI tested upon arrival at the feedyard with any positive cattle being removed and quarantined in a separate pen according to feed yard policies.

STRUCTURE OF THE FLORIDA-FED BEEF CHALLENGE

- Cattle will compete in pre-determined categories (i.e. feeding performance, carcass quality) with an overall winner being determined by scoring. Prizes will be given to the overall winner, second place and third place group.
- When the visual average backfat thickness reaches 0.5 backfat cattle will be sent to harvest. Not all cattle in the contest will process on the same day or same time. Fat cattle will be sent in groups of 35-40 head to fill a semi load. Extension personal and Feedyard management will determine when an animal is “finished”.
- Feedyard will provide opportunity for feed finance of the cattle.
- Cattle should arrive at the feedyard October 1, 2021. A 14 day “warm-up” period will be given before the challenge begins. Projected out dates will be April - June.
- Producers will be given a confidential producer code. The performance data for producer’s cattle will not be shared with others. Prize winners will have some of their collected feeding and carcass data publicly announced.
- The University of Florida extension service will tally all data and hopes to announce the winners of the Florida-Fed Beef Challenge in the summer of 2022.
